GUIDELINES FOR APPLICATION FORM

For a thorough description of the VA approval scheme (approval of products for water supply and drainage systems) and the information which is to be included in the application form, see "VA-approval, Guidelines for applicants".

In the application form fill in at least the following: **APPLICANT, MANUFACTURER, PRODUCT** - Name and type, as well as **DATE** and **SIGNATURE**. Information relating to the other items may be enclosed as an appendix.

When applying for a renewal, fill in the following: Previous approval number, **APPLICANT, MANUFACTURER, PRODUCT** - Name and type, as well as **DATE** and **SIGNATURE**. Where the product has been altered or its name/type specification changed since the latest approval and no previous notification has been given to that effect, please provide information as to the nature of the change.

APPLICANT - MANUFACTURER

Where the applicant himself is not to be indicated in the approval as the holder of the approval, please state the name of the holder.

Data relating to the manufacturer shall only be provided where the applicant (the holder of the approval) and the manufacturer is **not** one and the same legal, responsible person. ETA-Danmark A/S reserves the right to require confirmation from the manufacturer that the applicant is entitled to apply for a VA approval.

PRODUCT

Nature

Please state the technical designation of the product, e.g. sanitary tap, check valve, drain pipe, floor drain, hot water tank, etc. Furthermore, please enclose brochure, specification of technical data, installations instructions etc. for the product. See also "VA approval - Guidelines for applicants".

Name and type

Please state the manufacture and type designation as well as any other designation under which the product is to be marketed. Where the product is available in several variants, please state the variants in questions, if possible by indication in brochure or the like. An approval may cover several variants, which are identical with respect to structure and water-technical properties and only differ in design such as e.g. taps or other fittings of different colours and/or operational handles.

Field of application

Please provide information on the intended use of the product in relation to the codes of practice for domestic water-supply installations and sanitary drainage - waste-water installations.

Examples:

Water pipes made of PEX for hot and cold water
Mixing tap for kitchen sink
Floor gully for concrete floor
Flexible set of hoses for technical purposes
Drain pipes and formed pieces made of PEH in buildings
Hot-water tank designed to central heating plant and district heating plant

Marking

Indicate the markings affixed to the product for identification purposes. Marking is mandatory and must consist of at least a mark of the manufacturer (logo, if any) and any type designation.

Comments

Provide any supplementary information. Where the product has previously been VA-approved, please state the approval number.

INSPECTION

Please state whether the product is covered by an inspection agreement, e.g. in connection with similar approvals from another country; if so, please enclose a copy of the said agreement.

DOCUMENTATION

Indicate the drawings, descriptions, test reports (Danish or foreign), approvals from other countries or other technical documentation accompanying the application.

DATE AND SIGNATURE

The application must be dated and signed by a person with the applicant who has legal responsibility.
